# 1. EXECUTIVE SUMMARY

---

## 1.1 INTRODUCTION

Government Degree College Udhampur is located at a distance of 65 KM North from Jammu. It is connected with rest of the country by road and rail. The College is at a distance of 3 Km from Udhampur Railway Station and 68 Km from Jammu Tawi, Airport.

The prestigious and majestic campus of this octogenarian college is situated on a hillock-top overlooking the river **Devika** also called as the **elder- sister of the Ganga** that has its **reference in the Puranas**.

The college is one of the premier institutions of Udhampur district and Union territory of Jammu and Kashmir at large. **It was established in 1961**. The first batch of **30 students was admitted to the college on 27th of June, 1961**.

At present this college is one of the leading institutions of higher learning in the Union Territory of Jammu and Kashmir. The College offers courses in the disciplines of Arts, Commerce, Science, BCA and BBA. We are also offering three PG Courses i.e. PG Chemistry, PG English & PG Hindi. Many courses of skillbased education have been started with the help of NIELIT and other institutions viz. **certificate courses in Tourism Management/THSC, Computer Application, Tally, Internet of Things and Data Entry & Office Automation**.

From the academic session 2018-2019 onwards and till date, a number of new courses have been granted affiliation and approval by Jammu University viz.: **PG Chemistry**, and Philosophy, Public Administration & Geology at Under Graduate level.

The College has a highly qualified and experienced staff, well-equipped laboratories, rich library, play-fields, Boys' hostel, Multi-purpose hall, Conference hall, Smart Classrooms with interactive, Wi-Fi enabled LED panels, Information Browsing Centre, e-content studio and many other infrastructural facilities.

The College has a splendid playground for Cricket, Football, Hockey, Tennis, Volley-ball, Kabaddi and Badminton.

The alumni of the college have been spreading the hue and fragrance of this prestigious institute in various fields of service of the nation and across the globe including including many members of faculty in different colleges and Universities of the J&K UT, in the country and abroad and also are achievers in different fields.

- Maximum sanctioned posts of teaching faculty are filled (90%).
- Teachers are encouraged for various Faculty Development Programs for academic updating and career growth.
- Academic calendar is followed in letter and spirit.
- Conduct of examination, continuous evaluation and Term End Examination is done as per Jammu University norms and the statutes are followed strictly.
- Courses offered to learners are student centric, participatory and interactive teaching learning is through continual assessment and improvement system like assignments, seminars, course projects and field visits etc.
- Admission process is transparent and fair. It is done on merit basis as per the available intake.
- College library namely Devika is important asset for the college students and staff. It is enriched with huge numbers of text, reference and heritage books, journals, e-journals and newspapers with automated system for the ease of students.

- College moves on a policy to promote social sensitivity, human value, self-reliance, National Integration and gender equality.
- IQAC is functional and suggests various measures to improve the quality and standards in each and every aspect of the college functioning.
- The college campus is situated on a hill top. It is neat, clean, green and environmental friendly.
- College has shifted to skill based education with the introduction of many new certificate courses and skill based academic courses in the degree programmes.
- Being a premier institution of the district, it acts as a Nodal college in the conducting of many competitive examinations and evaluation processes.
- College conduct the examination process as per the norms of affiliated University in a confidential manner.
- In addition to five UG programmes, college also offers three PG programmes.
- College has a big playground, gymnasium and other sport facilities for the students to play outdoor as well as indoor games.
- The college has two Hostels for Boys.
- There are six Residential Quarters for staff.
- Dedicated canteen facilities Canteen facilities are available.
- Subject tours, field visits, industrial visits, picnic and education tours are conducted from time to time.
- There are two buses in the college and transport for girl students is available.
- All students are covered under Insurance.
- A well-established Botanical garden with some species exists as an asset.
- All laboratories are well-equipped.
- The college has a Conference Hall and Multipurpose Hall for the conduct of programmes, conferences, workshops and various programmes of students interest.
- Browsing Centre and e-content generation and archiving lab are well established.
- For distance learners support system like IGNOU and Distance Learning Centre of Jammu University has been established in the campus.
- ATM facility for students and staff are available.

### **Institutional Weakness**

- Slow pace of expanding the infrastructure like class rooms, laboratories, Examination Hall and General store room.
- Un even student teacher ratio in humanities and permanent faculty. There are 39 academic arrangement staff engaged to cater the need of teaching learning in the college.
- Research base is weak.
- Research projects in the college are scarce.
- Less numbers of MoUs and collaborations with Local, national, International institutes, corporate houses, Govt. and Non-Govt. Organisations.
- Registered Alumni Association process is yet to initiate. College has a data base of many alumni and their meets are conducted intermittently. Though alumni club exists in the college.
- Placement and career opportunities in the college are less. Thrust of students is still on pursuing conventional courses.
- Poor academic and socio-economic background of students at entry level in the college.
- Scarce amount of funds available for conducting students, staff and institutional activities at a high and full-fledged scale for optimum outcome.

## **Institutional Opportunity**

- The college needs to improve more on counselling, mentoring, and tracking the progression of students with respect to academic, research and competitive fields.
- MoUs and Collaborations with other institutions, corporates, Govt. and NGOs for IT , skill courses and research at National and International levels is the area where institution can tap the potential.
- Introduction of B.Voc. and skill based courses in letter and spirit under National Education Policy 2020 which can become a source of employment to students.
- Introduction of new subjects related to NCC, value based education, soft skill and sports.
- Focus on green energy generation in the form of solar energy can be encouraged as an alternate source of energy.
- Thrust on Research Ecosystem for consistency, efficiency and efficacy related to societal issues
- More focus on technology oriented courses in the wake of employment opportunities.

## **Institutional Challenge**

- Integration of Technology and pedagogy during the implementation of National Education Policy 2020 in the upcoming session with new multidisciplinary approach.
- Combination of new major minor courses and shortage of class rooms.
- Maintenance and repair of existing old administrative and academic block subject to non-availability of grants.
- Alumni support and their participative approach.
- Raising funds mechanism by Alumni and local industrialists for college development.
- Regular placement drives for students.
- To device and execute a plan of action for training faculty to have maximum number of MoUs with relation to their subjects/ courses.
- Plan and execute a policy in collaboration with parent department for a vibrant research, innovation, incubation and start up driven research ecosystem.
- Blending of offline studies along with online MOOC courses with the implementation of NEP 2020.
- Improvement of counselling, training, placements and tracking the progression of students with respect to academics, research and competitive fields.
- Greater numbers of MoU's, collaborations with other Institutions, corporate/business houses, industry, Government and NGO's in all fields.
- Student Exchange Programmes.

## **1.3 CRITERIA WISE SUMMARY**

### **Curricular Aspects**

Govt. Degree College Udhampur, being a constituent college of the University of Jammu, strictly implements the syllabus as is notified by the Jammu University for Undergraduate programmes in B.Sc., B.A, B.Com, BBA,BCA and PG programmes in English, Hindi and Chemistry. The CBCS system is operational in all the programmes. The curriculum is framed keeping in view the modern trends and advances in Science,

Humanities, Social Sciences etc. At the start of every semester, timetables are prepared according to the workload specified in the UGC Regulations. Each department distributes the classes to the teachers, keeping in mind their specializations and expertise. Within the broad framework of the University's Annual Academic Calendar, the College designs its detailed Academic Calendar and timetables before the commencement of the session for smooth and effective functioning. The seamless execution of curriculum delivery is ensured through departmental meetings and appropriate pedagogy for each paper is identified. Periodic assessments of students are undertaken through written assignments and tests as per the norms of the University in a time-bound manner. Besides the regular programmes the college offers a short-term certificate course in Entrepreneurship conceived and designed by faculty members in consultation with external experts. Some teachers of the College are a part of the curriculum design and paper setting committees of the University of Jammu. Issues of professional ethics, gender, human values, environment and sustainability are weaved into the pedagogy. The College also has a Women Development Cell (WDC) to address the issues specific to women. The IQAC has designed and maintained a feedback system for the Students and Alumni. For the last two years, all the classes were held in the online mode via Wiseapp and Google Meet. As a measure to improve curriculum planning and implementation, teachers participate in faculty development programmes/workshops.

### **Teaching-learning and Evaluation**

The necessity of education is "Teaching – Learning" which is relevant for knowledge societies to flourish and create a civilized nation. This criterion focuses on teaching-learning and evaluation. The college adopts the student-centric learning and experiential learning as its corner stone in academic process. The college follows a transparent admission process and the institution focuses on the improvement of learning experiences of the students as soon as they are admitted to various courses. The teachers are concerned about various types of learners like slow and advanced learners. The field trips for the students are conducted by the departments like life sciences, earth sciences, commerce and management for their first hand experience. The students of management department go for summer internships to have an exposure of corporate organizations. The institution is totally enabled in terms of ICT and IT tools with the latest technology, equipments and devices, fully equipped computer labs and internet connectivity. The laboratories of life sciences and earth sciences are fully equipped with the latest devices and equipments to expose students to up to date knowledge. The college organizes national and international conferences, workshops, seminars, interactive lectures, online extension lectures and awareness campaigns for students, teaching and non-teaching staff of the college. Along with the general degree courses, many short term courses and add-on courses are available for the students of diverse interests. The students have an opportunity of accessing the course contents of different subjects and information regarding their teachers, syllabi, general academic information through the indigenous portal of the college. The college library has a treasure of many books, journals, newspapers and magazines. The college has a well-qualified and subject expert faculty. The institution also relies on mentor-mentee relationships. The college faculty is involved actively in setting of question papers and evaluation of answer scripts. The results of internal assessments are uploaded on the website of affiliating university so that the results are declared in time. The whole process is kept transparent and confident. The college organizes various activities on a regular basis with strong media coverage to aware and informs the stakeholders and media at large. The teachers are committed and dedicated in imparting knowledge and support to students in various perspectives. The strength of the students has been increasing every year and there is a regular assessment of students through assignments, tests, preparatory tests, etc. The class teachers monitor the progress of students and maintain a constant interaction with them. There is a strong feedback system of the college which takes care of the various problems, suggestions and recommendations of the students. The students are often counseled for academic improvement and to solve any family or financial problems. The result analysis of examination and assessment is carried out and remedial measures are adopted. Remedial coaching as and when required is at place for the

academically weaker students. Advanced learners are encouraged and supported to put in efforts to secure ranks at the university examinations and guided to face competitive examinations to pursue higher levels of education.

### **Research, Innovations and Extension**

Research output at the college has got a leap jump since the last submission of the SSR. A number of papers have been published by the faculty in the UGC-Care listed and highly reputed journals at national and international levels.

The college as well as the parent department has initiated process for creating a research ecosystem with creation of college level research committee as also the college as a spoke under the hub-spoke model of the higher education for the propelling of research activities.

To generate impetus and bringing the faculty and researchers, scholars and experts on one platform, the college organised FDPs, Workshops and One National as well two international conferences.

The faculties of the college from mathematics has taken the lead in guiding the PhD scholars and at present two members of the faculty are acting as co-guides as being recognized by the Universities from where the scholars are pursuing their PhD. The faculty members are also the peer reviewers of recognized journals and members of reputed associations like ELTAI, MELUS and EFSLE in English, Sahitya Akademi, Dogri Sanstha, Rashtra Bhasha Prachar Samiti, Hindi shikshan Mandal, JKAACL for faculty of Modern Indian Languages and Indian National Science Congress.

To cater to the growing demands and changing scenario of the employment and progression the college has initiated the students to add-on courses in Computer application, tally, software designing, Internet of things and entrepreneurship development programs

The college under National education policy shall be starting with blended mode of teaching along with the initiation of skill/ BVOc Courses for which a good amount of budgetary provision has been made by the parent department. The college has started moving in the direction by establishing E-Content Centre, HUB-Centre for Agriculture technology, IT and Electronics and Spoke centre for Food Technology, veterinary sciences, horticulture and sheep husbandry etc.

Extension activities are organized in the college through IQAC by NSS, NCC, Red Ribbon Club, and the society in collaboration with different departments and agencies for the optimum exposure to the student volunteers and cadets and maximum benefit to the society. The college has conducted activities and programs with relation to Beti Padhao Beti Bachao, Vittiya Saksharta, Swachh Bharat, Fit India, Atamnirbhar Bharat, Sakhshit Bharat and activities under Azadi Ka Amrut Mahotsav and large number of socially relevant activities.

The college encourages students for experiential learning by organising field trips, lab trips, hands on training and collaborative internship programmes. The participation of the students in RD and Independence Day Parades at national and local level is a regular feature of the college.

For Quality initiatives in the fields of Research, Innovation and Extension the IQAC of the college has been and is working in a missionary mode.

### **Infrastructure and Learning Resources**

GDC Udhampur was established in the year 1961 and is spread over 12.5 acre of land. The college is offering three PG courses in three well established separate blocks, English, Hindi and newly constructed Chemistry block. Besides the PG courses, there are separate blocks of Botany, Zoology, Biotechnology, Sericulture, Physics and Electronics, BBA, Commerce, BCA, Geology, Geography, Music, and Psychology. During the last five years, more focus has been made for the development of infrastructure; as a result of which most of the budget allocation has been spent on this front. College has total 28 lecture halls all enabled with Wifi and LMS facilities. There is one fully furnished Conference Hall measuring having 150 capacity and equipped with ICT facilities. Of 28 lecture halls, 13 are renovated and modified as smart class rooms with all modern facilities and ICT tools like Wifi, LMS, LED and interactive boards. Besides, there are around 21 labs. a Zoological Museum, a Girl's Common Room, a dispensary, two canteen, ATM, a College Vatika for girls and a capacious sports field. There is also an mini conference Hall, IQAC room, General staff room, Principal Chamber, establishment section), Incubation center, Skill Development centers (under the hub and spoke model of HED, etc. College also has a Botanical garden having many special/ rare species, houses a greenhouse, and a Water Harvesting tank. There is a Multipurpose Hall used for indoor games, and also used as Auditorium and Gymnasium. The stage of the Multipurpose Hall is adequate to host cultural activities like Dance, Painting and Drama, etc. More than 125 computers are possessed by the College and all of them are connected to the internet. The college has a separate functional English laboratory with dedicated numbers of computers and language communication system as well as software. A Browsing Centre has been newly established in the college and 22 computers are connected to the internet. The college has a dedicated High-Speed Optical Fibre Internet Connection from Airtel with speed up to 300mbps. The college has a well-established separate Library complex and enriched with books of all the subjects. An adequate allocation of the funds are reserved for the purchase books during the last five years. In total the library is having more than 69 thousand books. Besides the College provides e-books, and e-journal learning to its students at a yearly subscription fee charged by the concerned agency. The automation of library has been made in the recent years using Integrated Library Management System (ILMS). Safe and pure drinking water is available to the students. Two 60 KVA capacity gen-sets provide an uninterrupted power supply to the campus. The college has two buses for providing to-and-fro services to the students. There is well demarcated and sufficient place of parking in the college for both staff and the students. The college has one Principal Quarter, three staff quarters, and two boys Hostels, of which one is for Gaddi-Sippi tribes

### **Student Support and Progression**

The student is the pivot human resource around whom the entire institution process revolves. The efficiency of the institution is defined by the amount and quality of human resources it has. The College has a long history of human resource development. It places a strong emphasis on providing a wide range of support services to its students in order to achieve these goals.

The college through a financial assistance and scholarship committee helps students who apply for scholarships offered by the UT and other national agencies, such as those for SC, ST, OBC, Pahari Speaking,



RBA and minority classes. Seminar workshops, extensions, guest lectures, field visits, internships, science exhibitions, employment fairs, and other events are regularly arranged by various departments for the benefit of the students. Anti-Ragging and CASH programmes are also conducted from time to time. The college Hostels accommodate students of far-flung areas. Counselling and job placement cells advise students on course selection, career and life opportunities, and so on. The placement cell of the college has arranged several placement drives.

Over the last two years, Google Meet, Wiseapp, Whatsapp groups, Facebook page, Google class room and the College website have also aided the student community in staying informed about college events and teaching learning process. The college owns a dedicated interactive web portal “Devika Cloud” with the facilities of admissions, notifications, Online teaching-learning, online e-contents, online assessments and examinations, online student satisfaction, surveys and reports, grievance resolution system etc. IQAC, NSS Unit, NCC Unit, College Magazine Committee, DSWO, and other committees have students as members on board. The college publishes the Devika Newsletter and college magazine in a regular manner.

## **Governance, Leadership and Management**

**Governance, leadership and Management** is of prime importance in any institution as it revolves around the vision and mission statement. For effective governance, leadership and management there are number of committees constituted every year to look after the working of college. Decentralization has been ensured for transparent governance. Grooming of leadership qualities among staff is ensured through membership of different committees, in different roles from time to time as well as participation in seminars, conferences, workshops, FDPs, orientation courses, refresher courses and other courses at institutional level and outside the institution. Leadership qualities among students are groomed by ensuring participation in different curricular and co-curricular activities at institutional level and outside the institution. NCC and NSS plays an important role in inculcating the sense of responsibility toward the society. Involvement of different stakeholders in policy making, its implementation and out-come is ensured through feedback and periodic review by IQAC keeping in view of Institutional Development Plan. Due to continuous efforts by College management there is lot of addition and improvement in existing infrastructure for ensuring quality education. Faculty as well as students are appraised of latest trends in teaching learning process on regular basis through different interactive programmes. Much focus has been laid toward technology based teaching learning process. Use of latest technology in office management as well as students related facilities is also ensured for transparent and accountable management along-with regular audits. In this regard use of BEAMS, Paysys, GeM, Devika cloud and other apps are of special mention. Since this institution is a Govt. Institution controlled by Jammu and Kashmir Higher Education Department every policy related to any matter is governed by Govt. rules and regulations. There is a set hierarchical structure for smooth functioning of the institution, moreover all the service rules are applicable to all the cadres. Institutional performance appraisal system is there and forwarded to controlling authorities as per its requirements. Use of e-governance in administration, finance and accounts, student admission and support as well as examination is in operation during the reported period. Different welfare schemes for teaching and non-teaching staff members are there in accordance with Govt. rules and regulations. IQAC and college management has ensured the implementation of previous NAAC Peer Team

recommendations for quality enhancement.

### **Institutional Values and Best Practices**

In terms of academic performance, finance, and administration, the institution

adheres to all statutory requirements and maintains complete transparency in all of its activities.

The institute recognizes and accommodates the needs of its female staff and

Students in terms of safety, security, and counselling, and has created appropriate provisions. College organizes sensitization programmes under Women Development Cell, CASH (Committee against Sexual Harassment), Red Ribbon Club, Nature Club, NSS/NCC, etc.

The institution has taken an ecological approach in campus maintenance, putting special emphasis on plantation, water harvesting, compost pits, water storage tanks. Students with special needs have access to ramps, disabled friendly washrooms, wheel chairs, walkers and other amenities.

The students take part in Swachh Bharat programmes, blood donation camps, disaster relief missions, open defecation free (ODF) programmes, Drug de-addiction and Awareness against Illicit Trafficking, Street Cause events, different subject field visits, educational tours, multilingual mushairas, cultural programmes, visit to old age and orphanage homes, all national and international days, events and festivals. Around seventy five percent (75%) students of the college hail from the rural areas and students of different socio-religious and socio-cultural backgrounds enroll and College is committed to cater all their educational needs.

The students are trained through regular courses like Human Values and Professional Ethics, Gender Sensitization, Women Writing with credit weight age.

College runs three postgraduate courses Viz. PG in Chemistry, English and Hindi and fulfils the needs of non-local as well as local students who cannot go outside the district for higher education due to some binding like financial or social.

Multidisciplinary/interdisciplinary:</p>	<p>Government Degree College Udhampur is one of the prestigious and decades-old institutions of UT of Jammu and Kashmir and is offering courses in all the streams (B.A, B.Sc, B.Com, BBA, and BCA). The focus on making education multidisciplinary is a significant step that will benefit all the stakeholders with far-reaching effects. The Government of India has put tremendous efforts into creating an enabling ecosystem for offering multidisciplinary education to flourish and making a difference to the students, who in turn will make an impact on the future of our country. With creative and open choice-based combinations of subjects, cutting-edge curriculum, and flexible options during the UG course, students</p>

can explore their areas of interest and also choose careers of their choice. Besides this, this kind of approach will foster intellectual curiosity, critical thinking, self-reflection, leadership, and teamwork skill with a sense of commitment, professionalism, and a heightened sensitivity to one's socio-cultural environment. Jammu and Kashmir had already announced to fully implement the National Education Policy (NEP) from the current academic session with a four-year Undergraduate Programme with multiple entries and exit options. It will also move to a uniform academic calendar which in turn will be synchronized to the national academic calendar. The college in this context has geared up and is ready and prepared with the available infrastructure (by making its optimum utilization) to run the multidisciplinary courses in context with NEP 2020. As the college is affiliated with Jammu University, the course structure and syllabi for the multidisciplinary undergraduate program are almost in the final stage at their end and will be implemented from the current academic session i.e. 2022-23.

## 2. Academic bank of credits (ABC):

Academic Bank of Credits has been established along the lines of the National Academic Depository (NAD), in the sense, that NAD is the backbone of ABC, where the students' academic data are held and academic awards are stored. The validity of these academic credits earned by students will be up to seven years and students can redeem these credits. The credits can be redeemed and students can seek admission directly in the second year in any university. As the validity of the credits would be up to seven years the students will have to re-enter within the stipulated time. Being the owner of academic awards, Academic Institutions must mandatorily register themselves under ABC via NAD. The University Grants Commission has amended the Academic Bank of Credit (ABC) regulation to bring all higher education institutions under the same platform. All universities, colleges, and autonomous educational institutions can now take part in the ABC system irrespective of their National Assessment and Accreditation Council (NAAC) rating and National Institute Ranking Framework (NIRF) ranks. Till this time, the college has not opened ABC but is in the process of making it operational and a nodal officer for the same has

	<p>been appointed to complete the activity of registering the college in the academic bank of the calendar at the earliest.</p>
<p>3. Skill development:</p>	<p>Another most significant component of NEP 2020 is encouraging employment by the inclusion of vocational education and training along with academic discipline. This ensures that the entire ecosystem of colleges and universities will now include vocational education as an essential part of their curriculum. NEP 2020 is a vital step toward restructuring the educational ecosystem with the aim of meeting the rapidly changing needs of employers. Professional learning institutions can play a vital role in facilitating academic learning, through their industry-based curriculum and mentoring. With the inclusion of professional re-skilling and upskilling these institutions also rope in Corporate India as an important stakeholder in ensuring in-job training. The college is also restructuring itself along the lines of implementation of this blend. The Higher Education Department UT of J&amp;K (the parent department of the college) is offering several programs at the UG and PG levels to promote the rich and unique knowledge of Indian Arts, Music, Sanskrit Literature, Linguistics, Urdu, Punjabi, Dogri, and mandatory awareness for ecology through Environmental Sciences. For the enhancement of skill and employability, the department of higher Education has identified 16-degree colleges to start Bachelors in Vocational courses (B.Voc) from the current academic session and this college is also amongst the sixteen colleges identified. Besides this the college has the potential to start short term Job Oriented Skill courses like Mushroom Cultivation, Cutting and Grafting, Silk Worm Rearing, Journalism, Electronic Equipment Maintenance and Repair, Creative writing, Teacher Education, Organic Farming, Fundamentals of Computer, Recycling the Waste and Waste Management, etc as these courses can be started in the college by utilizing the available human and material resources.</p>
<p>4. Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course):</p>	<p>At present, our education system is reeling under the ills of Westernization, excessive privatization, and exclusion from its cultural underpinnings. This alienation from indigenous wealth and knowledge repository has not let us achieve much in the domain of education in the 21st century. We all know that</p>

just achieving the literacy targets is insufficient for the intellectual enlightenment of the masses. Thus we need to incorporate Indian Knowledge and Tradition into the fold of education in such a way that it becomes our 'way of life. Being home to the youngest populations in the world, we also need to realize the demographic dividend for the growth and development of our country. It is thus the moral responsibility of all the stakeholders in the Indian educational system to strive for quality and equitable education for all by extending stimulating courses on the Indian Knowledge System to the students at a young age so that they know the importance of "doing what's right", with a logical framework for making ethical decisions. Therefore, all curriculum and pedagogy, from the foundational stage onwards need to be redesigned which is strongly rooted in the Indian and local context and ethos in terms of culture, traditions, heritage, customs, language, philosophy, geography, ancient and contemporary knowledge, societal and scientific needs, indigenous and traditional ways of learning. Further India is a treasure trove of culture, developed over thousands of years and manifested in the form of arts, works of literature, customs, traditions, linguistic expressions, artifacts, heritage sites, and more. The Department is offering several programs at the UG and PG levels to promote the Indian rich knowledge in Arts, Music, Sanskrit, Linguistics, Urdu, Punjabi, Dogri, and Environmental Sciences. The college shall implement this vision to core through NEP, however, from time to time the college has acquainted the students with regional as well as National culture, languages, heritage, and knowledge systems by organizing different activities on a number of occasions.

5. Focus on Outcome based education (OBE):

Outcome-Based Education (OBE) is a student-centric teaching and learning methodology in which the course delivery and assessment are planned to achieve the stated objectives and outcomes. It focuses on measuring student performance i.e. outcomes at different levels. The college always strives to achieve academic excellence by making this whole process student-centric. The knowledge, skills, and attributes that students take away at the end of a program or course are more valuable than what, or how, something is taught. Outcomes are usually expressed in terms of a mixture of knowledge, skills, abilities,

attitudes, and understanding that a student will attain as a result of his/her successful engagement in a particular set of higher education experiences. Assessment of students is usually done through formative and summative evaluation with a focus on knowledge comprehension, application, analysis, and synthesis. Now with the advent of this policy, this whole process of evaluation is going to change with the main focus on formative than the summative evaluation.

6. Distance education/online education:

The NEP 2020 has given a special focus on online education. A number of Universities and institutions are conducting pilot research studies for maximizing the benefits of digital learning in India. Online tools and platforms like DIKSHA and SWAYAM are being upgraded with new insight into training content, in-class resources, assessment aids, profiles, etc. that will allow seamless interaction. It also focuses on the creation of public digital and interoperable infrastructure that can be utilized by multiple platforms. The present age is driven by digital technology and the whole globe is interconnected via World Wide Web (www). The internet has enabled, equipped, and connected both the educator and educand by bringing them together under the virtual roof. Due to this, the concept of a virtual classroom is already popular across the globe. Thus, in the modern era, the role of online technology in providing education is vital and with its flexible nature, online educational technology has gained popularity. Online education is now more accessible to the less privileged groups in comparison to the centralized classroom education system. In the context of online education, the college has already made operational its own Learning Management System(LMS) with e-content of different subjects available for all the students free of cost. The college has also established an e-content studio with ultra-modern equipment for the quality recording of lectures and the creation of virtual content. The college has geared up its various departments and the learned faculty members for the creation of online courses and content by providing all the necessary assistance and support required. This college is governed by the Higher Education Department UT of Jammu and Kashmir and is affiliated with Jammu University. It is offering courses in all streams with

almost all the subjects. The college has enough potential in the form of human and material resources and by making optimum utilization of existing resources, the Institution is all prepared to implement all the directions and instructions of the Higher Education Department UT of Jammu and Kashmir in context with the implementation of NEP-2020 in a phased manner.

1. Govt. Degree College Udhampur is a constituent college of the **University of Jammu**, which strictly implements the syllabus and **Annual Academic Calendar** notified by the University. The college has an important role in revision and **upgradation of the curriculum** through the participation of all Heads of Departments as members in the meetings of **Board of Studies**.

6. Conventional chalk and board method is integrated with ICT-based methods of flipped classroom and blended learning. **Internships**, within and outside the college, are encouraged as part of student-centric methods of curriculum delivery.

7. Departments regularly assess and evaluate the **percentage of syllabus** covered and discuss any problem encountered by the students and teachers with the Principal.

8. An **Ability Enhancement Compulsory Course** on English/Hindi/Dogri/Urdu communication helps the students to improve their verbal, non-verbal and written language skills.

9. The study material for every subject, both offline and online, is made available by the library, which enables an enriching curriculum delivery.

1. Govt. Degree College Udhampur follows the **Academic Calender prepared by the University of Jammu**. The dates of commencement and completion of semesters and schedule for admissions and examinations are enlisted on the **Academic Calender and college prospectus** published at the start of Academic year.

2.The students are informed about the Academic Calender and the same is uploaded on the **College website and displayed on notice boards**. All the rules regarding pass **percentage required,promotion rules, reappearance for improvement and grade points** are available on the College website and college prospectus.

3. The schedule for **End-Semester examinations is fixed by the University of Jammu** and the same is displayed on the college website and notice boards for the students.

4.The **Internal Assessment carries 20 marks as mandated by University of Jammu**. The examination committee of the college announce the schedule of assessment test as per the Academic Calender. The evaluation of Internal Assessment tests is done in a time-bound manner and the grievances of the students, if any, are properly addressed.

5. Continuous Internal Evaluation of the students is done by the faculty members through innovative teaching pedagogies and techniques like **in class discussions, field visits**, talks on syllabus-related topics etc. Apart from classroom education, a number of co-curricular activities like Symposia, Seminars, Debates, Quizzes, Group Discussions etc. are organized by the institution to provide experiential learning to the students.

6. Internships, within and outside the College, are encouraged as part of evaluation for **BBA students**. The college strictly monitors the attendance of the students and they are required to fulfill the minimum attendance criteria i.e., **75% to appear in the Term-End Examination**.

7. For the papers that are accompanied with hands-on training, practical examinations are conducted in the College's Laboratories along with **internal/external viva-voce**, as per the requirement.

8.The college promotes the faculty to upgrade themselves by attending the **Refresher Courses**,

**Orientation Courses, MOOCs and Faculty Development Programmes** from time to time.

9. Due to the Covid-19 Pandemic, the Academic Calender for the even semester 2019-20(January-May) was revised and extended. According to the University of Jammu guidelines, the second and 4th semester students were promoted to the next semester, based on their internal assessment and previous year performance. ## 2.2 Catering to Student Diversity

### 2.2.1 The institution assesses the learning levels of the students and organises special Programmes for advanced learners and slow learners

#### Response:

The institution stresses upon the improvement of the learning experiences of the students as soon as they are admitted to the various courses. The institution has a very well elaborated process for identifying the learning levels of students and it is also considered that the process should be such that the poor learners are benefitted at maximum. The students who are perceived to be poor learners include the students having poor performance, students from weaker sections of the society, intellectually disabled and have lesser resources. These students are identified through a proper mechanism that includes classroom performance, assessment and evaluation by the teachers, regular parent-teacher meetings, class discussions, workshops, seminars, and competitions. Guest lectures and expert talks are organized by various college committees so as to give students proper exposure to the industry and academia. Also, many awareness programs are organized in the college which is of societal importance. A Career counselling committee is also framed by the college to guide the students about their career choices. A fully-fledged library with all the appropriate resources is available for the students along with a good reading area and a well-equipped browsing centre which help students to learn in a better way. Also, competitive guidance books for various competitive exams (GRE/GATE/CMAT/GMAT/NDA/UPSC etc.) are also readily available in the college library.

For slow learners, the special classes are undertaken by the concerned teachers (online as well as offline) where the doubts are cleared by the teachers. The teachers work rigorously on their own plan of action to clarify the doubts. The most common technique for the improvement of the slow learners is the one to one interaction with the students which motivates the slow learners the most and by encouraging them to participate in the regular classes. The students are encouraged and their performance is monitored regularly. The students are oriented through various awareness programs in the college along with the video lectures, presentations and group discussions in the classes. The Institution has formed different committees that involve students and teachers who work hand in hand in conducting different processes and activities.

## 2.3 Teaching- Learning Process

### 2.3.1 Student centric methods, such as experiential learning, participative learning and problem solving methodologies are used for enhancing learning experiences

#### Response:

The institution provides a student-centric approach to learning. The students are made to participate actively in the learning process through a sequence of activities so that the desired outcome is attained. This process helps the students to be active stakeholders and it also boosts their confidence. The teachers directly engage the students to increase their confidence, concentration, knowledge, skills and values. First of all, the diverse students are facilitated by being allowed to comprehend at their personal levels so that they can become proactive and grasp information at their own pace.

Teachers try to make classes as interactive as possible through various methods like audiovisual methodology, language labs, industrial visits, field visits, projects, online lectures etc to provide experiential and participative learning.

The assessment of students is done in such a way that every student is focused individually. The project presentation, written assignments, seminars etc are used to enhance the learning of students. The students submit the written assignments which must be completed independently by conducting research on the assigned topic in order to build confidence, develop writing abilities, sharpen writing style, as well as instil an interest in research activities. Students' presentation skills are also improved through seminars, project presentations, and viva.

The college puts stress on experiential learning by supplementing the classroom lectures with practicals. The periodical excursions, subject-specific fieldwork and field trips are organized by the college to provide real-time exposure and motivation to the students. There are short term skill-specific courses and add on courses for the skill training of the students. The internship programmes are undertaken by various departments for enhancing the skill base of the students by collaborating with various industries.

Group discussions, guest lectures, brainstorming sessions, presentations and interaction with the experts belonging to different fields is organized by different committees of the college.

The college is totally committed to the enhancement of the learning experiences of the students through various activities.

**Response:**

The institution is totally enabled in terms of ICT tools as there are 28 classrooms with the latest technology equipment and devices, fully equipped computer labs and internet connectivity with a power backup facility for unobstructed ICT enabled instruction in the classroom. 127 Computers, 43 printers, 22 laptops & Internet ( VPN Connections) have been installed in almost every teaching department as a learning resource. The library has a treasure of more than 70,000 books & 06 journals, 17 newspapers and 15 magazines. An E-library facility under N-List (National Library and Information Service Infrastructure for Scholarly Content) is also available in the institution. The departments which require separate labs have separate labs which are upgraded from time to time with the latest teaching aids and equipment and their periodical maintenance is ensured. It is very essential for the students to learn and master the latest technologies. The teachers are using the traditional methods of teaching by integrating them with Technology-driven equipments.

The Department of Physical Education and Sports Sciences and the Sports Committee are responsible for augmenting adequate facilities for sports and games by purchasing sports equipment, maintaining and upgrading the equipment and the allocated areas. On an average 500 students use the sports facilities

- **Multipurpose Hall:** Multipurpose Hall established in the year 2013 measuring 2632 Sq.Ft area used for indoor games. More than 500 students per month visited the Multipurpose Hall for Indoor Games. For outdoor games, college playground of an area of 340X460 Sq. Ft. has Cricket Pitch, Volleyball courts and Badminton Court. The facilities are used by the students and staff and also for activities of District Administration like celebration of Republic Day and Independence day etc.
- **Gymnasium :** Established in Multipurpose Hall in the year 2013 measuring an area of 20X30 sq. ft. with the financial support of UGC; It has the necessary infrastructure. More than 200 students per month visit the Gymnasium.
- **Auditorium:** Multipurpose hall measuring 2632 Sq.Ft. of area is used as Auditorium at times.

**The Annual Sports Calendar is prepared by the college as per University sports calendar, which includes various inter-collegiate tournaments held at the University level. The college also hosts State level Silver Rolling Volleyball Tournament (Men and Women)**

- **NSS:** NSS Activities are carried in the Conference Hall, Multipurpose Hall, College Vatika or outside the College Campus as per the nature of the activity. College also has a NSS room.
- **NCC:** Regular parade/ Practice is held in the College Ground. Special meet is held in activities like Dance, Painting & Drama in the Conference hall and Multipurpose hall. College also has separate NCC Room.
- **Yoga Centre:** Gymnasium and multipurpose hall and college vatika (120X340 Sq. Ft.) is used for regular yoga activities.

##### Cultural activities:

Cultural Committee of the college is responsible for the purchase and maintenance of instruments, equipment and costumes, and travel expenses within and outside the Campus.

The stage of the Multipurpose hall is adequate to host the cultural activities like Dance, Painting & Drama and Annual Day Function. Conference Hall having an area of about 1120 sq. ft. with 150 capacity is also used for Farewell Parties and other programs organized from time to time.

### 4.3 IT Infrastructure

The institution has a dedicated **Optical Fibre Internet Connection with speed upto 300Mbps**.

The college has built its own **dedicated WiFi Network** designed and implemented by the Computer Science Department and IT Department. The network consists of Dedicated Firewall and Switches, and more than a dozen D-Link High Power Access points which cover the entire campus. Authentication and Access for both faculty and students is provided through a **Central Gateway Portal**. Security is maintained by a firewall device which restricts access.

Entire college campus including all the departments are covered by the network. Each department is additionally provided with network connected PCs and printers. A central **Xeon Server** with 64GB of RAM is also installed in the college which hosts the **ILMS (KOHA)** and provides access to students to the library database both locally and through the internet. For this purpose, access points (PCs) are provided to the students in a space in the library designated for this purpose.

The Backbone of the entire network is **High Speed Fibre Connection** taken from Airtel which provides up to 300Mbps speed. Additionally, a 20Mbps connection and five BSNL broadband connections have been taken as backups in case the main connection fails. The Principal chamber is equipped with a BSNL broadband connection which provides backup for official purposes in case the main connection is not available.

**Response:**

All the affairs of the institute are managed by various committees headed by the Principal. The Principal of the college convenes meeting of IQAC Coordinator, convener of Advisory, Academic, Purchase and Development committees appraising the quorum about status of financial position of the institute. **The college Development committee** headed by the Principal monitor the civil works carried in the institute and is entrusted with **maintenance, upkeep and up gradation of infrastructure. Funds are sought from Administrative Department** for the same. The convener Development committee conducts periodic checks to ensure the maintenance of the infrastructure. All HODS and conveners of different committee are informed to submit requisition for items required for smooth conduct of affairs of the institute for the academic year. After thorough deliberations, budget is prepared and funds received are allocated keeping in view students' strength of each department. Purchase is done through proper tendering or on **GEM portal** following all codal formalities. The HODS are accountable to the Principal who organize efficiently workforce, maintaining duty files containing details about their individual fixed responsibilities etc. Every department maintains a **stock register** of the available equipments. **Annual verification of the stock** is carried out at the end of year. The Lab. Assistants under the supervision of concerned HODS maintain the efficiency of the college computers, accessories and other lab. equipment. In order to maintain the **hygiene**, adequate in-house staff is employed so as to provide a congenial learning environment. Daily cleaning and maintenance of classrooms, laboratories, staffroom, and washrooms is assigned to supporting staff designated for each floor. **Two full time gardeners** assisted by ground staff maintain the green cover of the campus. The campus is monitored through CCTV surveillance cameras. **The Department of Physical Education** along with the **Sports Committee**, manage the sports infrastructure, including cricket pitch, well-equipped gym, and courts to play volleyball. Chess, carrom, table-tennis and badminton are facilitated and maintained by the Department. Every year the **Department prepares a yearly calendar of**

**the sports** activities to be held in the college and tries to meet the set target in line with the sports calendar prepared by the **University of Jammu**. Our College has a well-furnished library accessible to the students and the staff throughout the year. The staffs deployed for its maintenance is well trained and the functioning is coordinated by a **professional Librarian**. The maintenance and utilization of library resources are the responsibility of the Library Committee. It allocates funds for purchase of new books and other requirements of the library. The library acquires the reading resources on the recommendations of the teachers. Some of the general and reference material and e-resources, needed by the library, are purchased by the Librarian in consultation with the Convener of the Committee.

Different parameters which revolves around administration, discipline, punctuality, teaching learning process, hostel facility, welfare schemes, financial management, campus enrichment and many more are aimed for improving the standards of Education in this institute through different committees. The institution stresses upon the professional skills of teaching and non-teaching staff and grooming of the students keeping in view qualitative improvement rather than quantitative aspect.

### 6.1.2 The effective leadership is visible in various institutional practices such as decentralization and participative management

#### Response:

Leaders and well trained trainers are the primary need of the society. Long-term leadership is essential and emphasis is being laid on human values to produce leaders with understanding of the society. The concept of worker participation as well as employee empowerment is of prime importance in the institution. **Decentralization and participative management** in academics and administration is integral part of management by ensuring participation in policy-making, framing guidelines, rules and regulations by involving staff and students through different committees in the beginning of the session. The composition of the different committees is changed every year in order to provide equal opportunities towards academic and professional development of all faculty members. There is close coordination among different committees, departments and IQAC to fulfill the policies meant for smooth functioning of institution and achieving its vision and mission. Feedback of stakeholders is always of utmost importance and is considered while deciding curricular and co-curricular activities to be conducted at institutional level.

At functional level the faculty members participate in different activities of the college by sharing their knowledge, experience and proper guidance on latest trends required in teaching as well as other parameters related to students as well as institutional upliftment. At operational level all the staff members actively participate in implementing the policies, procedures, and framework designed by the management to achieve vision and mission of the institution. Office staff is involved in executing day to day support services for students and faculty. Alumni involvement, interaction with parents and industrialists happen through specific events as well as engagements. Inputs of students through HOD's and teachers are taken into consideration while framing any developmental policy for the institution to meet the standards of quality education at par with any National level institution. For execution of institutional plans during any session the Principal in consultation with staff council appoints various committees headed by senior faculty along with other faculty members and students representatives. Decisions or demands from any Department or stakeholder are considered and processed through concerned committee based on merits and

finally submitted to Principal for approval. Due codal formalities are followed in any case. Leadership qualities among students are developed by involving them in organizing different academic, co-curricular and extracurricular programmes with teachers in facilitative and guiding role. Thus, the decentralization practice of the college has a significant impact in academics and overall development of its stake holders.

## 6.2 Strategy Development and Deployment

### 6.2.1 The institutional Strategic / Perspective plan is effectively deployed

**Response:**

The Govt. Degree College, Udhampur has a well prepared strategic plan to fulfill the infrastructural requirements, academic development, extra curriculum activities, sports, NCC, NSS and other academic developments. The targets have been set up with the extensive consultation with all the stakeholders including, faculty, students, alumni, industry etc. The development plans have resulted into the creation of smart class rooms, up-gradation of all the class-rooms, addition of new class rooms over existing Chemistry Block, Virtual class room, internet facility to all the departments, well-maintained central park dedicated for girl students, addition of new laboratory equipment's/chemicals/glass wares/consumable items and a very rich botanical garden. The up-gradation and improvement of Laboratories, departmental infrastructure, hostel facility, College canteen, College landscape and other developmental activities are

carried out regularly in consultation with different committees as per their domain. The library and reading room facility with rich collection of books along with internet facility has been kept at the disposal of students where the students can have access to different study material. Availability of Journals, Magazines and Newspapers in the library is also ensured for overall grooming of the students. The NSS and NCC Units of the College play a crucial role in community outreach programs. Keeping in view their importance, institutional level help is always extended to the students for better outcome.

The College has started an English Language Lab, although with a small infrastructure but is likely to be developed into a complete Lab. very shortly. College has browsing center with 22 No's of computers supported by high speed internet which are being used by faculty as well as students. E-content center with recording, editing and broadcasting facility with high speed internet is also added in the college for online mode of teaching or blended mode of teaching. Devika Cloud platform developed by the college is part of LMS and is being widely used by stakeholders. The College has different committees for effective administration, CCTV facility and creation of Proctorial Board for monitoring discipline. Different facilities required by students and staff are always prioritized in consultation with IQAC. Remarkable initiatives includes Pink toilet for females, washrooms for specially abled students, ICT enabled class rooms, internet facility etc. The IQAC has framed a **Draft Policy** for the institution keeping in view the different requirements for the welfare of institution which covers the interest of all stakeholders.

**Given below is one activity successfully implemented based on the strategic plan:**

#### **Examination and Evaluation Process Reform:**

Based on the policy towards examination and evaluation some reforms were suggested and adopted by college for a systematic examination and evaluation process which works on the pattern similar to University of Jammu in the following ways:

- Internal assessments on prefixed dates with common date sheet and centers of examinations by the examination committee of the college.
- Question papers setting and distribution, Answer sheets distribution, collection, evaluation, attendance etc. on the pattern of university examination.
- Circulation of awards of students after evaluation for inviting any query.
  
- Provision of re-examination, reassessment for genuine cases.
- Special examination and evaluation provision during pandemic

### 6.2.2 The functioning of the institutional bodies is effective and efficient as visible from policies, administrative setup, appointment, service rules and procedures, etc.

#### Response:

Quality and excellence are constant endeavors of the institute. There are robust steps that ensure high quality in teaching, research, and governance at the institutional level. Since our college is Government College, it has no private body as governing body. The administrative control lies with the Department of Higher Education. However the governance in the college is managed by the Principal with the support of different committees. These are reviewed periodically by different bodies. Course feedback, annual appraisals, etc., are some of the formal mechanisms to ensure quality.

**The hierarchy of organizational structure:** The College is governed under the administrative control of Department of Higher Education, Government of Jammu and Kashmir through the Ministry of Higher Education. The Higher Education Department is headed by Principal Secretary/ Commissioner Secretary to Govt. of Jammu and Kashmir, who is supported by Special Secretary, Additional Secretary, Financial Advisor, Director Colleges and Law Officer, which are further subordinated with Under Secretaries. The Principal works under the supervision of Higher Education Department. The work of Principal is to administer the college who is further assisted by teaching staff (Associate Professors/ Assistant Professors/ teachers on academic arrangement) and non-teaching staff. The teaching staff in each department is headed by the senior most faculty member. Department of Physical Education and Library remain under the control of Physical Training Instructor (PTI) and Librarian respectively with overall supervision of Principal. Next is non-teaching staff who discharge their duties in Establishment Section, Laboratories and Library. Establishment section is run by Section officer, Senior Assistant, Junior Assistant and Computer Assistant. Account section is headed by Accountant and Account Assistant. Among other Non-teaching staff includes, Lab. Assistant, Lab. Bearer for Labs, Lib. Assistant, Chowkidar, Gardner, plumber, carpenter, electrician and Safaikarmcharies. Fourth class employees remain at the lowest rung of hierarchy. Besides this hierarchical set up, college constitute many committees to support the college operations. There are many committees headed by a convener/ coordinator who can delegate decisions in its standing committee with an overall supervision of the chair. These functionaries include number of committees which are responsible for ensuring smooth functioning of the college.

**Service Rules, Procedures, Recruitment and Promotion Policies:** The service rules of the teaching and non-teaching staff are the same as reflected in CSR and rules put forth by different regulatory bodies of the UT Government. The selection process for all gazetted posts is through JKPSA in accordance with UGC regulations and for non-teaching posts it is through JKSSRB in accordance with Govt. rules and regulations. Service rules are pre-defined and are applicable in-toto for any cadre or post. For teaching staff, PTI and Librarian, UGC regulations are applicable in addition to state/UT regulations. The discrepancies in the service promotion if any is forwarded to the Administrative Department. However, the



grievances of the staff are managed under the Grievance Redressal Cell of the College.

## 6.3 Faculty Empowerment Strategies

### 6.3.1 The institution has effective welfare measures for teaching and non-teaching staff

**Response:**

There are some welfare schemes in the Institute for teaching and non-teaching staff in accordance with Govt. guidelines, some of such applicable schemes includes, National Pension Scheme (NPS), General Provident Fund (GPF), State Life Insurance (SLI), Cash in Lieu, Janta Group Insurance, Medical Insurance scheme (Mediclaime), Medical imbursement, Loan from Banks, Dearness Allowance, Child Care Allowance, Travelling Allowance, House Rent Allowance, Medical Insurance/Allowance, beside this any medical and health care facility covered under any Govt. scheme is also applicable like most recently launched health scheme "Ayushman Bharat Scheme" which is Govt. of India's free hospitalization cover of Rupees 5 Lacs to every employee. Teacher welfare schemes introduced by the University of Jammu for the welfare of needy teachers is also there. Moreover different types of leaves can also be availed as and when required in accordance with rules. Besides, the College has in-campus residential facility for Principal, hostel warden as well as to limited number of teaching staff. Gym facility along with indoor games and outdoor games facility is also kept at the disposal of teaching staff. Multipurpose hall can be used by teaching staff for organizing different types of activities related to them. Women Empowerment Cell meant for redressal of grievances and other needs of female staff members is functional for any type of grievance.

**Non-Teaching**

National Pension Scheme (NPS), General Provident Fund (GPF), State Life Insurance (SLI), Medical imbursement, cash in lieu, Janta Group Insurance, Medical Insurance scheme (Mediclaim) and Loan from Banks, Dearness Allowance, Child Care Allowance, Travelling Allowance, Medical Allowance, House Rent Allowance, different types leaves and all schemes covering health related issues launched by Govt. are also applicable for non-teaching staff. Residential accommodation to limited number of non-teaching staff is also there. Gym facility, indoor/outdoor game facility is there for over all wellbeing of non-teaching staff.

The employees who are on temporary basis are provided with financial assistance from the college local Funds and by pooling the amount amongst the staff of the college in case of medical exigencies and any natural calamities. The College staff has come up with structural welfare schemes for students and staff who are financially weaker and assistance is provided on case to case basis.

#### 6.3.5 Institutions Performance Appraisal System for teaching and non-teaching staff

**Response:**

Performance Appraisal System in any institution is very important because it directly determines its efficiency. The performance appraisal system is in tune with vision and mission of the college for greater efficiency in realizing the core institutional objectives. College is following the PBAS- Performance Based Appraisal system laid down by UGC for evaluating the faculty covered under such guidelines. PBAS focus

on three categories like a). Teaching, Learning and Evaluation related activities b). Co-curricular, Extension and Professional Development related activities and c). Research Publications and Academic Contributions. API scores are calculated for each category by faculty members for submission of their cases for next grade, which are further evaluated by Higher Education Department and accordingly placement is accorded to next higher grade. The faculty members also submits self-appraisal report in the form of Annual Performance Report (APR's) in the prescribed Performa at the end of every academic year which is evaluated by the Principal of the College and later on the same is reviewed by the higher authorities. The teacher maintains records of teaching, examination and evaluation, record of different committees of the college in which he/she is member, research and publications if any during the reported period to calculate API scores and the same is then filled in the APR's/API. These APR's/API are considered for clearing probation as well as for next placement of the faculty. These APR's/API are forwarded to J and K Higher Education Department for further analysis as per required parameters for determining the level of satisfaction for that particular post. Overall performance of non-teaching staff is also forwarded to J & K Higher Education Department as per required format once submitted by concerned official. However, Principal of the college collect the feedback from HOD's of different departments as well as anonymous feedback from the students before forwarding the self-appraisal report of the concerned employee. Before placing the staff to next higher grade the evaluation of APRs by the principal and acceptance from the Director Colleges Higher Education Department is must.

**Student feedback on teaching and overall functioning of the college:** At the end of every semester students give feedback/suggestions on different parameters required under quality assurance like, teaching methodologies by their subject in-charge, infrastructure required for teaching, and overall exposure in curricular and extra-curricular activities, which are later on analyzed by the IQAC and report is prepared accordingly on different parameters and submitted to the Principal for further action wherever required. Student's feedback is also collected for non-teaching staff in order to make the performance appraisal system more transparent and effective.

## 6.4 Financial Management and Resource Mobilization

### 6.4.1 Institution conducts internal and external financial audits regularly

**Response:**

To ensure the utilization of different grants received by the college for developmental activities from different Govt. agencies during any financial year, the college accounts are maintained properly and audited for each financial year regularly. The Internal Audit Committee is in place which is headed by a senior faculty member preferably with commerce background which conduct internal audit of the college local fund as well as other funds/grants received from UT Govt./erstwhile state Govt. from time to time. The College authority always tries to ensure the utilization of different funds and grants at the disposal of college as per their allocation in a transparent manner through different committees and at the

end of financial year such expenditures are duly audited by authorized authorities for which audit report is submitted to the concerned authorities. The institute has established mechanisms for conducting internal and external audits for every financial year to ensure financial compliance. The external audit is carried out by an auditor appointed by Govt. to execute such audits. Such persons conduct the audit in accordance with auditing standards generally accepted in India to find out the fair and trueness of the accounts. Financial audit is conducted once in a year after the completion of financial year. No major objections are found in the audit during reported period by the auditing authorities however minor queries are answered as per requirement and procedure.

#### 6.4.3 Institutional strategies for mobilisation of funds and the optimal utilisation of resources

**Response:**

The college has well established mechanism for mobilization of funds and optimal utilization of its financial resources kept at its disposal. The key focus revolves around financial requirements of all academic departments and other units in a judicious manner. The various means from where financial targets are achieved includes;

1. Admission fee from students, Auctions if any during the year or building usage charges (Internal Revenue Generation-IRG/ Local Fund Resources) and distribution of the same under different

heads which are then utilized as per requirements and laid down provisions.

2. Financial support from UGC, as the college is recognized under section 2(f) and 12(B) of UGC. The funds released are utilized in the College by the drawing and disbursing officer who is the Principal of the college. The utilization certificates of grants released by UGC is sent to UGC after utilization of the grants duly attested by a Chartered Accountant (CA). The Audit and Finance department of the state Government also audits the accounts regularly.
3. Infra-structure grant under RUSA scheme.
4. Research grant under DST
5. Grant from J and K Higher Education Department under Capital Expenditure Grant (Capex). The college has constituted different committees for full filling the different requirements of the college as per the merit of the demands. Financial implications are discussed with the chair who in consultation with the Accountant of the college accord approval. The funds which are received from above mentioned sources are overseen by Accountant of the college who is appointed by Finance Department of J and K UT. Every year Principal convene the meeting with some important committees like, **College Advisory/Purchase/Development committee etc. in the beginning of the session and these committees** draft Action Plan for next Academic and Financial year. These proposals are formulated and approved after threadbare discussions and finally get approved by the DDO in consultation with College establishment and Account section. Some new proposals are submitted to different agencies for funding whereas already sanctioned grants and funds are monitored periodically for their effective and transparent utilization.

The college Development Committee assist the college administration in preparing the DPRs through different executing agencies like R&B (PWD), JKPC and other such approved agencies for getting the new grants from different funding agencies as well as utilization of sanctioned grants for different projects as per the codal procedures. There are some more grants which are provided to college for infrastructure enrichment like, Material and Supply, Material and Equipment, Books and stationery etc. for utilization of such grants the requirement lists are obtained from HODs and accordingly the action is taken. All the orders are made through tendering/e-tendering/GeM/DGS&D etc. following the codal procedure. College Purchase committee plays an important role in any purchase for the college and ensure the quality of such purchases. For ensuring transparent financial transactions the payment to suppliers is made through cheque system, through BEAMS or PFMS portal.

**6.5.1 Internal Quality Assurance Cell (IQAC) has contributed significantly for institutionalizing the quality assurance strategies and processes**

### Response:

The Internal Quality Assurance Cell of the college is very important in planning and execution of different

action plan and has contributed significantly in improving the teaching learning environment along with overall grooming of students by taking new initiatives as well as refining the existing practices. The IQAC has been successful in its endeavors since its establishment. The cell has meaningfully contributed to the prior cycles of accreditation since 2006, as well as putting every effort for the current cycle. In the whole process for assuring quality in teaching learning process, it involves chalking out of new goals for every academic session in the beginning and effective implementation of the same in rest of the session. IQAC has ensured all such efforts by following a well-defined mechanism for achieving academic and administrative excellence. The cell has not only strategized the quality but also institutionalized the process through some of the following means which includes;

Addition of more Smart class-rooms, addition and improvement in existing infrastructure, Exposure visits of the students, Framing and Implementation of IDP, Implementation of recommendations of previous NAAC Peer Team, transparent administration, ensuring implementation of quality initiatives by IQAC, scope of career advancement of teaching staff, focus on adoption of innovative strategies for improving the academic and administrative efficiency of the college, focus on institutional best practices their analysis and outcomes, Use of Advance teaching Ideas and brain storming sessions for students and teachers, Focus on Institutional Development Plan, academic excellence, extension programmes, students grooming, through IQAC, refinement in teaching learning and evaluation process, students counselling, CCTV monitoring for security, focus on transparency in administration, Feedback of stakeholders, improvement in student centric facilities and so on. all these initiatives are meant for assuring quality at institutional level.

## **TWO PRACTICES INSTITUTIONALISED AS A RESULT OF IQAC INITIATIVE:**

### **1. Implementation of green practices in the campus:**

The IQAC proposed to initiate various green practices to maintain eco-friendly college campus through different activities like tree plantation, plastic eradication, paperless work, clean and beautiful campus, save energy, awareness programme on renewable energy, waste management. For implementation of green activities IQAC distributed these activities among various departments. IQAC constantly takes the feedback about the result oriented implementation of these activities every year. Because of these practices recently college received the award of green campus from District administration.

**2. Enrichment of ICT infrastructure for improving the Academics:** The use of ICT tools has become an integral part in teaching learning process. Govt. Degree College Udhampur is quite committed to maintain quality of teaching learning process through the use of ICT. IQAC always encourage teachers to utilize these tools in class room teaching and laboratories. IQAC prepare the plan to include the use and enrichment of ICT infrastructure expecting from each department. The IQAC has advised the administration to enrich the ICT infrastructure by purchasing and installing advance ICT tools, broadband internet, Wi-Fi facility etc. As a result of these initiative creation of Virtual class room, addition of more smart class rooms and enrichment of existing ICT tools became possible. Periodically teaching and Non-teaching staff are trained to use these tools. Use of ICT and social media has played an important role in fulfilling the aspirations of the students during pandemic.

**Response:**

IQAC play an important role in reviewing of teaching learning process, structure and methodologies of operation and learning outcomes on regular basis in a systematic way. Periodic meetings of IQAC coordinator along with IQAC members with HODs and other stake holders is carried out to review the functioning of the college. The focus always remain on the core agenda of teaching learning process, its evaluation and implementation. Feedback collected from students, staff, alumni and other stake holders is analyzed and its recommendations are forwarded to the concerned quarters through Principal for their redressal. Keeping in view the set objectives and goals, the outcome of the deliberations are discussed with stake holders for their implementation under the overall supervision of Principal in coordination with IQAC. In the beginning of every session the future Institutional Development plan is prepared keeping in view different requirements and their importance for effective implementation of steps required for teaching learning process which includes, teaching pedagogy, teaching learning outcomes, infrastructural requirements, evaluation process and role of ICT in grooming of the students besides other initiatives as per their demand and requirements. Faculty members are provided with ample opportunities for improving their skills by participating in different programmes, trainings, workshops or short term courses aimed for improving the teaching learning process. For fulfilling the students aspiration in terms of teaching learning process number of initiatives have been taken by college administration in consultation with IQAC. It includes upgradation of ordinary class rooms to smart class rooms with all ICT facilities keeping in view the importance of audio visual aid in present day teaching learning process, improved library facilities with high speed internet and access to e-resources as well as other books available in the library, browsing centre, mentor mentee groups creation for overall guidance and redressal of their genuine issues, initiatives for overall grooming of the students through different student centric programmes, focus on participative and problem-solving based teachings trends and techniques, field trips, society outreach programmes through NCC and NSS, Awareness programmes on different burning issues. The overall impact of all such steps helped in achieving very good result percentage in the first semester as well as final semester examinations with top positions by the students of this college.

### **Action Taken Report:**

The college has taken the following steps toward the recommendations of the NAAC Peer Team, 2016:

- Part time permission for Ph.D granted in favour of five faculty members during the assessment period and 05 teachers has completed their Ph.D.
- P.G.Chemistry has been started during the year 2018, in addition to existing courses like P.G. English and P.G. Hindi. Geology (2018), Philosophy(2018) and Public administration (2020) as one of the subject at U.G. level are also introduced.
- In view of NAAC Peer Team recommendations upgradation of existing class rooms and labs with interactive Board and LED Panels equipped with high speed internet has taken place and its number is 21.
- Faculty members are encouraged for research as well as participation in national and international conferences from time to time. The institute has also organized number of conferences and other programmes for faculty development.
- Full library automation is in progress and library has been equiped with ICT enabled services.
- Number of initiatives has been taken for collaborative linkages in the form of MOUs.
- Much focus has been paid on ICT resources and band width has been increased for the benefit of students.
- An effort has been made toward establishing the language lab. which is functional under the supervision of English department.
- Remarkable achievement has been made in sports and co-curricular activities in the form of winning different prizes at UT and National level by our students. Governor Silver Rolling Trophy in volley ball is of special mention.

##### Response:

The college has an excellent ambience for gender equity and inclusiveness with a thrust on providing safety and security, counselling on gender-specific issues and separate space through girls' common rooms. The regular observation of **International Women's Day** on March 8th is given accentuation while preparing the academic calendar. The College has a dedicated **Women's Development Cell**, consisting of female and male staff, who plan events like **Women's Day** and **gender-sensitization programmes** and play a key role in addressing the issues of all the female students in the college. Every year, prominent social activists, resource persons from the Women's Commission, female achievers, bureaucrats and luminaries from the judiciary are invited for interactions at the College with an objective to maximize awareness among the community about status, and socio-economic freedom from stigmas, violence and biases. Female students are accompanied by female faculty members during the visits/ educational tours or programmes outside the college campus. The college provides a transport facility for the female students and staff with two dedicated buses for the same. All entry points have gatekeepers who keep a check on the strangers and monitor the entry into the college campus. The institute also keeps a visitor's log register at the entry gate to keep a regular record of the persons entering the college premise. Dedicated **CCTV cameras** are placed at all important locations to have regular and close surveillance. The college has an **Anti-Ragging Committee** to ensure strict compliance with anti-ragging measures and has **special care for the girl students**. The college has a well established **Department of Psychology** with very renowned faculty. Their psychological support is of great help to address anxiety, stress, facing failures, homesickness, academic worries, etc. The College through its **First Aid centre** provides medical help to needy students free of cost. It is worth mentioning that the girl students participate in every activity and have brought laurels to the college.

Major significant efforts launched by the College Administration exclusively for female students and staff:

- Girls Common rooms with attached bathroom and dedicated sports area for the girls to play games like chess, carrom board, etc.
- The facility of Pink / green toilets for female students and staff.

- Separate NCC Unit for female students.
- Separate seats in NSS Units for female students.
- Separate reading section for female students in College Library.
- Empowering the women through Women Development Cell (WDC).
- Creating equal opportunities and a secure environment for all through CASH (Committee Against Sexual Harassment and Equal Opportunities).
- Equal opportunity for female students in different spheres and activities of the College.
- Gender Equity programmes for female students
- Celebrations of International Women's Day on 8th March

- Dedicated books and magazines for females students
- Regular security audit mechanism through Proctorial Board
- Dedicated surveillance infrastructure developed to avoid and check any untoward happening

**Solid Waste Management**

- The organic solid waste is put behind the Hostel building in the vermi-compost which serves as raw material for producing organic manure.
- The college has succeeded in reducing the use of plastic on campus. The waste produced is segregated at the source by providing separate dustbins for wet and dry waste. Throughout the campus, dedicated dustbins have been placed in strategic locations, and the safai-managers of the college systematically dispose of them every day through the vehicle of the Municipal Council of Udhampur of the J&K Government is taken for management and processing. However, the college is committed to implementing more viable solid waste management strategies at the institutional level, such as composting and solid waste incineration and processing.
- After verifying through the stock verification committee that an item is unusable, solid plastic garbage such as broken plastic, furniture, iron scrap, and wooden waste is put in the storeroom. After following the codel procedure, the abandoned things are then auctioned with the help of the college management. The seller transfers the auctioned products to the industry for reuse and recycling.

### **Liquid Waste Management**

Liquid waste is well managed, and no harmful or unsanitary waste is allowed to enter the main sewer. Sewage from various washrooms and pantry units is drained through underground pipelines and put in septic tanks before being disposed of in the soakage pits.

### **E-waste management**

Electronic waste, such as computers, broken chips, CDs, batteries, hard disks, fluorescent bulbs, LED CPUs, monitors, abandoned mobile phones, printers, CD drivers, etc., is collected through proper channels from all the departments, libraries, hostels, Offices, etc. and is handed over to the storekeeper of the college. The waste is transferred to the vendor support by the approved vendor under the supervision of the Principal, Auction Committee, and storekeeper of the college observing all codel formalities for recycling and disposal.

### **Biomedical waste management**

Regardless of the fact that the College is almost entirely free of Bio-medical waste as per guidelines by the Jammu and Kashmir State Pollution Control Board and Superintendents of Govt. Hospitals of UT of Jammu and Kashmir, the college uses puncture Black, Blue, Red, Green, and Yellow bags and cans for managing Biomedical waste.

### **Waste recycling system**

Despite the fact that the College is almost "No Polythene Zone," the College has come up with the concept of constructing a prototype for turning polythene material into gas and biodegradable material with the help of the Departments of Chemistry and Biotechnology.

### **Hazardous chemicals and radioactive waste management**

Very small amounts of such chemicals are used in Life Sciences, Biotechnology, and Chemistry. The most desirable is to reduce the quantity of waste at its source or recycle the materials for some other productive use. The remaining waste is temporarily stored in the laboratories of the particular department in a properly

prescribed manner and after the completion of the concerned semesters, the said waste is disposed of properly and legibly.

- Prevent exclusion of students from online examinations due to lack of access to technology or lack of technological literacy or expertise
- Facilitating online evaluation and gradation of answer sheets in a transparent manner with scope for grievance redressal
- Time bound evaluation of answer sheets so that University schedule for the same is adhered to

## Practice:

- In view of the COVID-19, it was not possible to conduct **examinations in the college premises as per traditional practice. Conduct of examinations online presented many issues, such as the technology to be used, the access of students to internet, the ability of students to use online portals for examination, and the feasibility of such practice considering the number of students enrolled in the college belonging to remote areas of Udhampur district. To facilitate the process, and to ensure maximum ease of access to students, it was decided to design and develop the examination portal in house, and the Website Committee in collaboration with the Department of Computer Applications took on the task at war footing. An Examination and Evaluation Portal was created for the Session 2020-21, wherein to attempt the internal assignment examination, students logged into the portal on the designated time and date as per the notified date sheet, and uploaded photos or PDF of their answer sheet. (For more details, kindly refer to student examination portal: <https://iqac.gdcudhampur.in/student.php>) A corresponding portal was also designed where teachers could remotely access student answer sheets and assign marks. (For more information kindly refer to evaluation portal: <https://iqac.gdcudhampur.in/evaluation.php> username: [naac@gdcudhampur.in](mailto:naac@gdcudhampur.in), password: [naac2022](#)).**
- **The task of conducting Private University Examinations for Semesters 1, 3 and 5 for all colleges in Udhampur district was also allocated to the institution, which was also undertaken in a transparent and efficient manner. (<https://iqac.gdcudhampur.in/student.php>) For evaluation of Private examinations, access to the portal was also provided to faculty from other colleges in the district. (<https://iqac.gdcudhampur.in/evaluation.php>)**
- **Phone numbers of faculty were provided to the students for resolving queries and difficulties of students, and efforts were made to prevent any exclusions because of the digital divide. Re-examination was conducted to accommodate students who were unable to upload their**

answer sheets to ensure no student was left behind. For this purpose a new date sheet was set and separate question paper sets were framed.

- The institution conducted online classes using various platforms. To ensure access of students to study material and e-Content, the college developed its own Learning Management System titled as the Devika Cloud (<https://devikacloud.in>) which hosts e-Content of various subjects and courses being run in the college. The portal allows public access to the study material, so that students from any college in the UT of J&K (and anywhere in the world) can access it, the syllabus being same as designated by the University of Jammu. It is pertinent to mention here that the institution is the first and only college in UT of J&K which has developed and implemented an LMS.
- As the pandemic showed no signs of slowing down in the latter part of 2020, the admission to the next semesters was also conducted online. This was necessitated by the fact that the college had been designated as a COVID-19 Care Center and patients were kept for observation in the institution premises. For Admissions, a dedicated in-house portal was developed by the Website Committee and the Department of Computer Applications. The entire process of admission was shifted to online mode, and helpline numbers were provided on the Institution Portal for addressing student queries. Provision was also made for students who were unable to fill the admission form online. Care was taken so that no student was excluded from the process. For more information, kindly refer to admission portal <https://iqac.devikacloud.in/admission.php>
- After admissions, students were mailed login credentials for Devika Cloud Online Learning Management system (<https://devikacloud.in>). The Devika Cloud Learning Management System contains unit wise course material, syllabus and interactive study aids for subjects taught in the college. Course material featured on the portal has been developed by the college faculty. Some Open Educational Resources have also been used as sources for the course material. The purpose of this exercise was to augment online teaching-learning process as well as to provide additional study aids for inculcating values of academic excellence in the students. For the kind reference of the NAAC Peer Team, login credentials have been created for the Devika Cloud (<https://devikacloud.in>) portal - username : iqac@gdcudhampur.in password: Naac@gdcudhampur2022
- It is pertinent to mention here that access to course material on Devika Cloud platform is public and open to students of all colleges. Login credentials are required only for assessments and exercises. Study material in form of videos, audio, powerpoint, PDF etc is available to all students and anyone on the internal can access.

## **Evidence of Success:**

- The Examination, Evaluation and preparation of result was conducted in timely and transparent fashion.
- Provisions were made that no student was left behind and re-examination was conducted at the end of the examination schedule to accommodate students who were unable to upload answer sheets for valid reasons. When the University results were declared, no student had been left behind due to the examinations being conducted online.
- Student awareness has increased regarding the use of online resources for access to study material and for taking examinations.
- The examination model and technology designed by the institution can be used in the future. The college encourages technology sharing, and welcomes invitations by other institutions to help them set up similar portals.



- **Mock tests were also conducted by the institution to ensure that students were made aware about the technical aspects of uploading answer sheets and submitting their paper within the stipulated time.**
- Admissions for session 2020-21 and 2021-22 were successfully conducted online through dedicated portals (<https://iqac.gdcudhampur.in/admission.php>)
- Students accessed study material from the Deviak Cloud platform. The link to the portal was shared among groups of other colleges as well, and system administration logs indicated that the course material had been accessed by a large number of users.

### **Problems Encountered:**

- **A large number of students of the college hail from remote areas of District Udhampur, and have limited access to Internet.**
- **Students who were unfamiliar with technology also found it difficult at first to use the portal to take examinations. To help such students Mock Tests were conducted to help students understand usage of the portal and to resolve their queries.**
- For attempting online examination and for filling online admission forms, some students who were not technically inclined took help of cybercafes for which they had to spend extra money. To assist these students places were designated in the college wherein they were helped in filling online forms.
- As some students could not upload answer sheets in time, the institution had to conduct their examination again and repeat the entire exercise for the benefit of the students.
- In order to cater to students of entire Udhampur district, staff had to work extra hours and efforts were made to manage and secure servers so that examinations could be conducted in smooth and efficient manner.
- It was found that students were often confused due to file formats, PDF file sizes while creating answer sheets for online examinations, and even entering their credentials on the portal. Consequently, the college introduced several changes to the system incorporating suggestions from faculty and student community.

### **Resources Used while implementing the practice:**

- **Programmers and System Administrators from the Website Committee and the Department of Computer Science**
- **Server and Dedicated Fiber Internet Connection**
- **Server Space purchased from DigitalOcean Service Provider**
- Beta testing of the software by faculty members
- Computer labs and Language Lab were designated for assisting students with filling online forms.

## **2. Title: Social Commitment and Community Outreach**

### **Objectives of the Practice:**

This practice tries to instill a sense of social service in our students so that they can recognize it as a larger conditioning framework of their education.

- To create environment consciousness among the students
- To foster the spirit of social service in our students
- We aim to raise our student knowledge of current socioeconomic gaps in income, education, health, and nutrition, as well as instill compassion and understanding for the needs of the underprivileged.
- Without social commitment, education is incomplete. We work for the betterment of marginalized section of the society and assist them through a variety of outreach programmes.
- As per **Mission of the College**, for stronger social connections and outgrowth programmes that make them enlightened and responsible citizens, promote and inculcate societal, cultural, national, and global relevance ethics among our students.
- **As per Vision of the College**, Udhampur College aspires to be a dynamic institution of higher learning dedicated to the intellectual enrichment of minds in order to generate valued and harmonious human resources capable of serving the community.

## The Context:

People from low socioeconomic backgrounds live lives marked by social inequity and a lack of possibilities, whether it be a lack of a sustainable livelihood or educational prospects, or a lack of access to healthcare and cleanliness. Education, on the other hand, is the only way to level the playing field. Education system in India can bridge these gaps by creating awareness among the youth of the nation. College provides a comprehensive education with the aim of maximizing students social sensibilities. The goal of the practice is to identify the needs and wants of the adopted schools and villages, as well as to address local issues such as restoration and cleanliness of natural springs (locally known as *bowlis*), Beti padao Beti Bachao, and drug abuse etc.

College in association with District Administrations and Others local NGOs work to build a long-term action plan to address social challenges. Udhampur College students are involved in the implementation of these goals and are given multiple opportunities to engage in empathetic community service.

## The Practice:

The college creates a synergy between its community work and outreach platforms such as the NSS, the NCC, the Eco-Club, the Heritage Club, the Nature Club, IQAC, various College Committees and the Alumni Association, thereby creating a multivalent and mutually renewing forum for meaningful dialogues, actions, and interactions. College organises programmes to sensitise youth towards their social responsibilities and the needs of the under-privileged. College itself provides the financial aid to the Orphans, disabled and BPL (Below poverty line) students under the supervision of Financial Aid Committee of the college. College always supports Udhampur District Administration for all Social Commitment and Community Outreach Programmes like Swachh Bharat Mission, Open Defecation Free Programme, Programmes under Azadi Ka Amrit Mahotsav, Baisakhi Mela or 'Basoa' as it is called in local parlance, is an annual event organized on the occasion of first Baisakh, usually from 13 /14 April to 15 /16 April every year on the bank of holy Devika river in Udhampur, etc., through participation of our staff and students.

## The Evidence of Success:

- **Efforts towards inclusion:** The NSS/NCC volunteers regularly visit Orphanage and Oldage Home at Udhampur, near to Head Post Office Udhampur. Students visit and interact with the occupants

and discuss issues related to health, hygiene and education. The volunteers also teach young children living in the Orphanage Home. They celebrate festivals like Diwali and other major festivals with them as a small effort towards inclusion.

- **Awareness for protecting the environment:** The Nature Club has played a seminal role in educating the students about the pressing needs to conserve the environment through eco-friendly practices. Multiple approaches to addressing environmental issues and locality cleaning drive have become a model of sorts for green initiatives in the area. Several plantation drives take place with the help of different communities and NSS/NCC students.
- **Financial aid and help:** College organizes visits to destitute homes like Orphanage and Old Age Home. These homes offer shelter to people who have been abandoned by their families due to financial or health issues. Our students interact with them, share their problems, and extend help wherever possible. College also provides Financial Aid to the needy and poor students (who belong to Below Poverty Line) of the college in every session through Financial Aid Committee of the College. Moreover, College also provides assistance to the College students to get the various scholarships from Government and private bodies.
- **Sharing and caring:** Festivals such as Lohri, Eid Ul Fitr, Republic Day, Independence Day, International Youth Day, International Women Day, International Yoga Day, Christmas Day, etc. were commemorated by a variety of activities.
- **Awareness programmes against alcoholism and drug abuse:** Alcoholism and drug addiction is one of the major problems in Udhampur. Not only do the men waste a major part of their family income on alcohol and drugs, they also indulge in fights with family and neighbors, under the influence of these substances. Student volunteers perform plays and organize rallies to highlight the evils of substance abuse through interaction with the people from Udhampur. College also organized different seminars, debate and painting competitions in collaborations with different organisations on such issues to aware the public of Udhampur.
- **Efforts towards creating a gender equal society:** College considers gender issues as one of the core issues to be highlighted and addressed. College also runs courses on Gender Sensitization (of Sociology), Social Change Development and Globalisation (of Sociology) and Indian Women Writing (of English) to aware the students on such issues.
- The college's various practices have been extraordinarily successful in terms of the intensity and scope of its vision and action. Not only has the institution been able to educate its volunteers and other students about the importance and nature of social work, but it has also been successful in reaching out to Udhampur locals. In general, students have become observant of the requirements of needy and poor people. Looking at their poor living conditions, students and the staff expressed compassion and empathy by initiating food and clothes distribution drives. Sanitary pads and other daily use items were collected in the college and later on distributed to these needy people through NSS and NCC students of the College. Through plays, rallies and other campaigns, we have been able to garner the attention of the Udhampur public towards these issues.
- To raise awareness about the threat of COVID-19, an online helpline has been started at (<https://www.dailyexcelsior.com/gdc-udhampur-starts-covid-19-helpline-offers-guidance-for-entrance-aspirants/>) in the month of March, 2020 where one can ask questions and clarify their doubts.
- The quarantine center with the capacity of 300 beds was set up at Government Degree College Udhampur by District Administration Udhampur in March 2020.
- Govt. Degree College was a dedicated Covid Care Centre (<https://covidrelief.jk.gov.in/CovidCareCentres>) from 25th March 2020 to 10 May 2021 and the staff of the college assisted the District Administration Udhampur to run the centre.
- Govt. Degree College was a dedicated Covid-19 vaccination centre and more than 5000 locals were vaccinated in the centre.

- The College itself has organised three times Covid-19 test with help of District Hospital Udhampur , i.e. one on 05/08/21 and other on 14/09/2021. More than 225 teaching, non-teaching staff members and students were tested. In continuation of commitment of the college towards community health Vaccination camps were organized from 14th May -24th May. More than 1200 people were vaccinated in this camp.
- Faculty members were deputed on COVID duty even during the peak of the pandemic and served to assist the administration in running the COVID Care Centers / vaccination centers / Quarantine Centers.

### Problems Encountered and Resources Required:

Illiteracy and poverty are interrelated and deep-rooted problems of our society. For a poor person, food is more important than education. Convincing people to send their children to college instead of sending them to work is very difficult. Consistent, continuous efforts are required to convince parents to send their children for higher education. The mindset of the inhabitants of the Udhampur had to be gradually changed by the efforts of NSS/NCC volunteers and faculty towards the said issues . The volunteers could eventually convince them of their well-meaning intentions through their sustained efforts at social amelioration. Alcoholism/drug abuse is a rampant problem in our society. Alcoholic abuse aggravates domestic violence. Student volunteers have made efforts to convince young men in the neighboring area not to take up alcohol/drug and save their future and their families. Planning visits to Orphanage and oldage homes requires resources. For regular visits and to fulfill their needs, a large amount of funding is required. More financial resources and local partners in this comprehensive endeavors are required.

### 7.3 Institutional Distinctiveness

#### 7.3.1 Portray the performance of the Institution in one area distinctive to its priority and thrust within 1000 words

##### Response:

Govt. Degree College Udhampur is dedicated to the all round development of its students. In this context the college organizes various competitions and events from time to time to facilitate physical growth of the students.

Volleyball is one of the most popular sport in Jammu and Kashmir and there have been a large number of National Volleyball Players/Coaches from the Udhampur district. The college has also produced a large number of volleyball players and they have represented the college through University of Jammu at national level. As a result of continuous and persistent efforts of the institution, the prestigious 'Silver

Rolling Trophy' for State Level Volleyball Championship (Men and Women) was instituted in the College by the Hon'ble Governor, NN Vohra himself in 2014 with the aim to promote understanding, brotherhood among the youth of all the three regions viz Jammu, Kashmir and Ladakh of the State through sports activities. Since then the College has been organizing the championship successfully on an annual basis. In addition to providing a platform to the potential sportspersons of this area to interact with their counterparts from other parts of the State, this event also works towards generating an understanding among the youth of Kashmir and Jammu Divisions. Every year scores of teams from different colleges across the state assemble in the college and compete to win the championship trophies.

In the first Silver Rolling Trophy organized in 2014, Government Degree College Udhampur clinched 'the first of its kind' Volleyball Trophy in men's category, while in women's category GCW Gandhi Nagar Jammu lifted the same in the 1st State level Inter-Collegiate Volleyball Championships (for men and women). The Annual Silver Rolling Volleyball Trophies were instituted and inaugurated by then Governor of J&K, NN Vohra at GDC, Udhampur (<https://www.dailyexcelsior.com/governor-inaugurates-state-level-inter-collegiate-silver-rolling-volley-ball-championship/>). Balwant Singh Mankotia, MLA and an alumnus of the College was the chief guest, while Dr Nutan K Resutra, Nodal Principal GGM Science College Jammu was the guest of honour on valedictory function. While giving away the trophies he congratulated the College for organizing this Championship.

"This was the first ever College in J&K to host an event of this magnitude in Sports for a Trophy instituted by the Governor. The dynamism of this College was exemplary for others to emulate. Both the teams displayed a high level of performance and neck-to-neck competition made us all awe-struck," Mankotia said. Dr Resutra, over-whelmed by the success of the Tournament, said that the College has capacity to perform beyond imagination." 31 teams drawn from across the State participated in this Tournament. The next Silver Rolling Trophy competition organized in 2015 saw even more participation from students across Jammu and Kashmir. This time again Government Degree College Udhampur (Boys) clinched the final of Governor's Silver Rolling Trophy in men's category while in women's category GCW Gandhi Nagar Jammu lifted the trophy in the 2nd State level Inter-College Volleyball Championship. 32 teams of the state participated in the tournament and exhibited their sports talent in the championship. Govt Degree College Udhampur defeated GGM Science College in the men's category, while in women's category; GCW Gandhi Nagar trounced GCW MA Road Srinagar (<https://www.5dariyanews.com/news/124704-Governors-Silver-Rolling-Trophy-championship-concludes>)

The Trophy was reinstated after a gap of one year in February 2017, and this time again Governor N.N Vohra inaugurated the 3rd Edition of State Level Governor's Silver Rolling Volley Ball Championship Trophy at the Government Degree College, Udhampur, in which 30 teams from the various Degree Colleges of the Jammu and Kashmir regions competed. Governor complimented Prof. S.S. Bhalwal, Principal of the GDC Udhampur, and his concerned colleagues for successfully organizing this Championship every year. Welcoming the participating teams, the Governor complimented the Principal over the rapidly increasing number of colleges in the State whose teams are participating in this annual tournament.

In December 2017, Hon'ble Governor of J&K State, Sh. N.N. Vohra inaugurated 4th Edition of State level 'Silver Rolling' Trophies (Men and Women) for Volleyball at Govt. Degree College Udhampur. In this edition 39 teams (31 men and 08 women ) from various colleges of the Kashmir province and some far off college of the Jammu division had participated in the mega sports event.

The college was upgraded in 2012 to teach up to Master's Degree level by the UGC, vide order no. 8-595/2011 (CPP-1/C) dated 23rd Jan, 2012. At present, the college is offering three PG courses viz., PG English, Hindi and Chemistry after the completion of graduation.

A sizable section of students joining this institution comes from such families who mainly depend on agriculture and are economically as well as socially very weak to support the education of their children. Further, virtual/digital classes and conduct of examination for students are successfully arranged for the benefit of students in the pandemic period. All the departments and the college library are Wi-Fi connected for providing best of class internet access to the stakeholders.

Besides the lush green and splendid campus of the college equipped with all basic amenities (with a backdrop of the Gangeda Hills); there are ample reasons for academic attraction and a conducive environment for optimum level of learning to the students. In its measures to remain eco-friendly and conserve every drop of water with a mind to **pay some debt back to Mother Nature**, the college has recently built a **Rain harvesting system in its botanical garden** as a water conservation measure. At the same time, under the green initiative plan, the college is in the habit of organizing plantation drives at all as well as special occasions. The botanical garden of the college claims to have many rare and culturally important species of plants and trees.

### Concluding Remarks :

Govt. Degree College Udhampur, a premier institution of academic excellence and achievement, was established in 1961. Since its inception it has been able to impart quality education to its students in connotation with its vision and mission.
